Dear Members of the Board,

The National Coalition Against Censorship is an alliance of national nonprofit groups dedicated to protecting freedom of expression. We are writing out of concern that the Alabama Public Library Service (ALPS) has suspended state funding from the Fairhope Public Library.

According to media reports,<sup>1</sup> the Fairhope Public Library received complaints from parents about books they considered to be obscene or harmful to minors. The library responded by revising its policies on sexually explicit materials for minors and relocating the young adult section. Despite these efforts, the library board believes that these actions are insufficient, and the library remains in violation of Rule 520-2-2-.03,<sup>2</sup> which requires libraries to "ensure library sections designated for minors under the age of 18 remain free of material containing obscenity, sexually explicit, or other material deemed inappropriate for children or youth." As a result, the state has withheld \$42,000 in funding from Fairhope Public Library.

This is potentially problematic because, as you know, very few books are legally obscene or "harmful to minors" under Alabama law. A book cannot be obscene unless the book, "taken as a whole, lacks serious literary, artistic, political, and scientific value."<sup>3</sup> Similarly, a book cannot be "harmful to minors" unless it lacks those criteria as to minors. It is very unlikely that professional librarians have purchased books which meet either of those criteria. Obviously, books that have passed the rigorous selection process for inclusion in public libraries have value for older minors, and by default should be considered valuable to the library community.

Furthermore, labeling these books as inappropriate does not obviate or eliminate your obligation to follow your own procedures for book challenges, nor to follow your constitutional duties under the First Amendment.

While not every book is right for every reader, the role of libraries is to allow all community members to make choices according to their own interests, experiences, and family values. However, no parent, student or community member may impose their views, values and interests on others by restricting an entire community's access to particular books.

For these reasons, we urge you to restore funding to the Fairhope Public Library. Additionally, if any books have been removed from library shelves, we recommend that you return them and keep them there unless and until a committee of professionals and community members determines that they should be removed pursuant to a proper challenge procedure.
